# Application

China has about 8,800,000 ha cultivated soybean fields with 14.5 million tonnes yield per year. Most soybeans are grown in the northeast provinces of China. Grey speck disease is one of the main diseases causing severe damage to soybeans. To ensure high crop yields and better crop quality, growers usually treat soybean fields with fungicides, such as Thiophanatemethyl.

Momentive's **Silwet 408** spray adjuvant can decrease the surface tension of pesticide spray treatments significantly more than other conventional spray adjuvants. This property typically leads to improved spray coverage, lower spray volumes, lower application costs and rapid uptake of agrochemicals into the plants. To demonstrate the specific benefits of silicone spray adjuvants, the Silwet 408 spray adjuvant was trialled with 70% Thiophanate-methyl WP fungicide spray treatments on soybean crops.

# **Results**

Field trial results demonstrated the following specific benefits resulting from the addition of the Silwet 408 spray adjuvant to the 70% Thiophanate-methyl WP spray treatments applied on soybean crops:

- 58 Kg yield improvement per hectare with the Silwet 408 spray adjuvant addition
- 50% spray volume reduction resulting to lower application costs
- 78% control with the Silwet 408 spray adjuvant addition (72% control with no adjuvant treatment)
