Spray Adjuvant to control Aphids on Medlar Trees






Application

China is the largest producer for medlar with over 900 kilotons yield per year. Aphids are one main pests causing severe damage to medlar. To ensure high crop yields and better quality, growers usually treat aphids with pesticides, such as acetamiprid.

Momentive's **Silwet 618** spray adjuvant is a typically cost-effective wetting agent, used where spray coverage is needed on foliar surfaces without any rapid pesticide uptake. Since Silwet 618 spray adjuvant is a unique spreader adjuvant with much lower surface tension than most commercial surfactants, it can enhance pesticide spray coverage even at significantly lower spray volumes. To demonstrate its specific benefits, the Silwet 618 spray adjuvant was trialled with standard 2.5% acetamiprid EC spray treatments on medlar trees.

Results
